

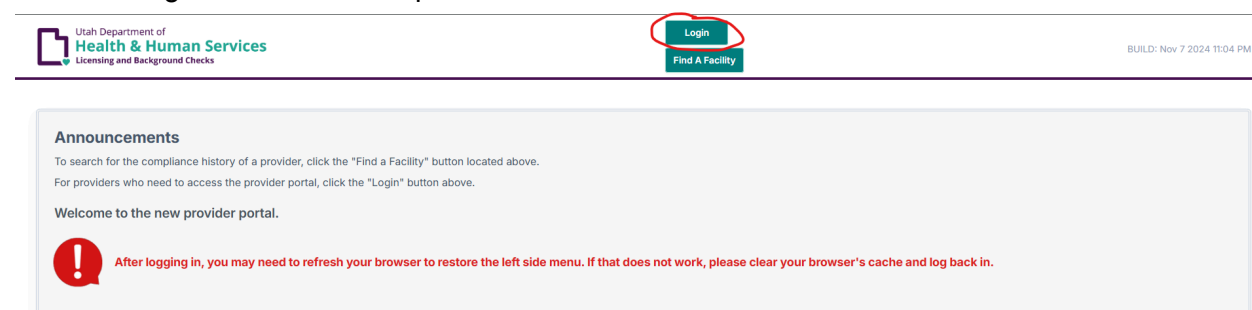
Case Management Recertification Application

Before you begin your application you will need to complete the first two following steps:

1. Recertifying CMs will be required to receive a score of 70% or higher on the Utah [DHHS/OSUMH Case Management Certification Training](#) provided by the Office of Substance Use and Mental Health. Save certificate of completion as a PDF to be uploaded.
2. Fill out the Application for Re-Certification as a Behavioral Case Manager form and have it ready to upload: [PDF Case-Mgt-Re-Certification-Application-04.06.25 update.ada.pdf](#)
3. Take the case management recertification assessment found here: [CM Recertification Assessment](#)


To create a UtahID account, take the following steps
