Davis County Government is the recipient of federal grant monies which specifically fund treatment for mental health and substance abuse programs at the local level. Upon receipt, Davis County remits these funds to Davis Behavioral Health (DBH) as contractually agreed upon for the above mentioned services provided. In order to provide oversight of these funds, I serve on the Board of DBH. As a Board member, I attend all scheduled Board meetings providing a means of control to ensure federal grant monies are used for their intended purpose.

In addition, a monthly meeting is hosted by the Davis County Commission where DBH senior leadership, including their chief financial officer, presents the financial statements to the Davis County Clerk/Auditor and finance staff. This meeting acts as a control mechanism to provide the Davis County Commission reasonable assurance that the financial and operating objectives of DBH are achieved and operating in compliance with federal and state guidelines.

That the Local Substance Abuse and Mental Health Authority are exercising sufficient oversight and control over public funds allocated for substance abuse and mental health programs and services.
